NOTICE

Reference is made to this Kendriya Vidyalaya's Tender Notifications uploaded in Vidyalaya website on 08.04.2021 duly published in leading Newspapers namely The Times of India & नवभारत टाइम्स dated 08.04.2021 regarding services pertaining to Watch & Ward, House Keeping Services and Beautification/Gardening with stipulated last date of submission of bid in prescribed format already available in KV Website by 1400 hours of 28.04.2021. But due to sudden spread of second wave of COVID-19 Pandemic and enforcement of curfew / lockdown in Delhi and NCR, the whole activities including stipulated opening of sealed envelope planned for 29.04.2021 also remained suspended till further order as per interim notification uploaded in Vidyalaya website on 27.04.2021 by the undersigned in compliance to GOI/ GNCT of Delhi/ DDMA orders/notification dated 19.04.2021 (No.381) 25.04.2021 (No.397), 09.05.2021 (No.415) & MHA order dated 29.04.2021 and subsequent MHA order dated 27.05.2021 in the matter.

Now, the undersigned, in view of partial relaxation of activities extended by Government of NCT of Delhi in its Order No 2/07/2020/Pt.File-III/432 dated 05.06.2021 and urgency for finalisation of tender process in the interest of Vidyalaya, it has been decided to open the envelopes containing "technical bid " already received in the Vidyalaya before the stipulated date and time as mentioned above, on **17.06.2021 at 10.30 AM** at the Vidyalaya Conference Hall in the presence of participating Firms/ Service Providers and the committee constituted for the purpose, by strictly following the protocol prescribed for prevention of the spread of Covid 19.

Therefore, all the participating Firms/ Services Providers, who had already submitted their tenders are requested to attend in person or depute authorised proxy with proper authorization letter with attested specimen signatures of the representative on **17.06.2021 at 10.30 AM**.

During the process of submission of the said tender, the Govt. of India, Ministry of Labour & Employment vide order No.1/16(6)/2020-LS-II dated 23.04.2021 has revised the Minimum Basic Rates & VDA w.e.f. 01.04.2021. Therefore, those firms who have already submitted their tenders are hereby granted an opportunity to **clarify as to whether they have submitted the tenders based on the Revised Rate applicable w.e.f. 01.04.2021 or the pre-revised rate, for its consideration in a uniform manner. Such clarification may be submitted in writing to the undersigned on or before 17.06.2021 at 10.00 AM.**

In case no clarification is received within the time limit prescribed, the tender already received will be considered based on the information already provided by the firm in the tender and no further correspondence in the matter will be entertained thereafter.
